STAFF AND ADVISORY BOARD



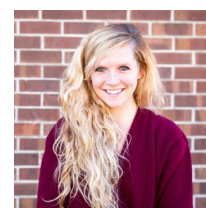

TEACHING

The Center manages the Human Rights Certificate program under the administration of the College of Law. There are currently 48 declared undergraduate students in the Certificate program. Center staff also teach First Year Seminars through University College and courses within the law school related to human rights, and frequently supervise undergraduate theses related to human rights. Staff also taught human rights related courses as visiting instructors in other institutions.

The Center also creates opportunities for learning outside the classroom. In summer 2019, UICHR awarded four students Kenneth J. Cmiel Human Rights Internship funding to support organizations pursuing human rights promotion and/or protection:

– Risham Singh, a medical student, will work for Iowa Harm Reduction Coalition to assist with Hepatitis C eradication efforts in both Punjab, India, and the State of Iowa;

– Nicole Hobson, an undergraduate, will work for Amazon Learning, assisting native medical professionals as they undertake health education and clinical outreach to Amazonian villages in the areas surrounding Tena, Ecuador;

– Autumn Moen, an undergraduate, will work for Safe Kids Worldwide, a global non-profit dedicated to protecting kids from preventable injuries, in Washington D.C.;

– Hope Kramer, a medical student, will work for Mokopane Hospital to support continuity of care efforts by physicians treating individuals living with HIV in Limpopo, South Africa.

In addition, Karla Olivas received the Burns H. Weston Human Rights funded internship award for 2019. She will work for Ayuda, providing legal, language, and social services to low income immigrants, in Fairfax, Virginia.

Academic Conferences

Iowa Human Rights Research Conference:

In partnership with the Iowa Network of Human Rights Academics, the Center organized and hosted the fifth annual Iowa Human Rights Student Research Conference at the Boyd Law Building on the University of Iowa campus on April 13. Over 100 people attended the conference, which featured presentations on a diverse array of international human rights issues. Thirty-two student presenters and 25 faculty members from nearly 20 colleges and universities participated in the conference.

The keynote address this year was provided by Dr. Njomeza Zejnullahu (pictured above right), a Fulbright visiting scholar at the University of Iowa College of Law from Kosovo, who spoke on "Human Rights in Kosovo: Progress & Challenges." Student papers accepted for presentation at the conference will be considered for the Weston Essay Prize and evaluated by the members of the Iowa Network of Human Rights Academics.

Faculty Development

The Center supports the participation of its staff and partnering faculty in national and international academic conferences, as well as training and networking opportunities, and creates opportunities for cross-disciplinary research and teaching about human rights. Select activities are listed below.

Adrien Wing made numerous presentations on human rights at universities and professional associations around the world, including in Singapore, Malaysia, China, Austria, Canada and Ireland. In August, she was the Keynote Speaker at the International Law & Racial Justice Workshop at the University of Colorado Law School, Boulder. At the 113th annual meeting of the American Society of International Law (ASIL) in Washington, Adrien was the moderator and presenter for a panel on “Diverse Perspectives on Colonialism and International Law.” Adrien is also a member of the Executive Council and Co-Chair of BASIL—Blacks of ASIL. In June, Adrien visited Iowa Law's new exchange partner, the National University of Ireland Galway (NUIG) where she lectured on the 2020 American elections.

Brian Farrell presented at multiple institutions and conferences, including at the Iowa State Bar Association Annual Meeting in Des Moines, and the Iowa Summit on Justice and Disparities in October. Brian visited NUIG in March and taught a course through the Irish Center for Human Rights.

Brian and his College of Law colleague Daria Fisher Page were recently named Bellow Scholars by the American Association of Law Schools. The Bellow Scholar Program selects scholars every two years to recognize and support innovative research proposals designed to improve the quality of justice in communities, enhance the delivery of legal services, and promote economic and social justice. Brian's project is titled "Rural Access to Justice in Iowa." This summer, Brian will become Chair of the International Law Section Council of the Iowa State Bar Association.

Amy Weismann participated in the first annual National Campus Human Rights Conference, organized by the Doria Human Rights Center at the University of Michigan in December.

Kathrina Litchfield delivered a presentation titled “Building a College-in-Prison Program” at Imagining America at Roosevelt University in Chicago in October.

ACTIVITY HIGHLIGHTS



FACULTY WORKING GROUPS

Human Rights Education, led by Andrea Cohen (United Nations Association of Iowa). This group successfully organized an “UDHR@70” poster exhibition, with multiple events around the state including in Iowa City last December. The exhibition included 40 posters made by various graphic artists from around the world that depict either a particular article or the UDHR in general, and 51 posters of stills tracing the development of human rights. The group coordinated with United Nations Association chapters and Human Rights Commissions around the state, as well as with other groups, such as the Dubuque International Day of Peace, to plan local exhibits.

Analyzing Workplace Laws through an International Human Rights Lens, led by Jen Sherer. The College of Law’s continued support for the UI Labor Center, resolved this Spring, has renewed the capacity of the working group to proceed with an analysis of university policies and their relationship to human rights standards, continue research on state statutes, and undertaking additional public worker rights workshops. This work will proceed during the 2019-2020 academic year.



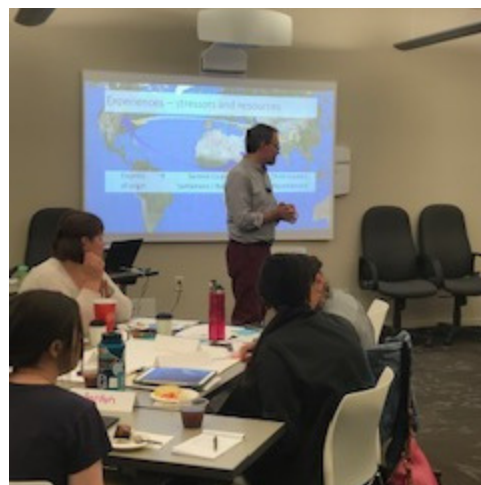

GRANT PROJECTS AND PROGRAMS

Promoting Culturally Appropriate Care for New Iowans: Amy Weismann and William Story (College of Public Health) received funding from the Iowa Bureau of Refugee Services as co-investigators on a three-year intervention-oriented study of mental health care provision to refugees in Eastern Iowa to develop culturally appropriate models of care. Dr. Brandon Kohrt (pictured at right) is the lead expert in the project and traveled to Iowa on June 3-6, to conduct trainings for approximately 100 health care practitioners, social workers and service providers in both Iowa City and Cedar Rapids. The Johnson and Linn County Refugee Community Consultant Teams, led by refugees from recently arrived communities, are proceeding to recruit team members and to initiate regular meetings. The Teams also participated in the planning of the June training events to ensure a community informed approach to the training of practitioners. These trainings, considered pilot programs, will be evaluated and revised and a second round will be organized for Fall 2019, which will also include a train-the-trainers workshop to multiply the effect of these undertakings across the state.

From October 13–20, the Center coordinated the third annual study visit for a five person delegation of diplomats from the Ministry of Foreign Affairs of the Republic of Kosovo. The week included lectures by Center and College of Law personnel, a public presentation, engagement with students, and a visit to Kosovo's consulate in Des Moines.

Global Education Institute for Teachers

The Global Education Institute for Teachers, a joint initiative of International Programs and The Stanley Foundation and co-sponsored by the Center, is a professional development opportunity for teachers across Iowa. This year's institute was held December 8–9 in downtown Iowa City. The 2018 institute focused on the global literacy concepts and 21st century skills of the Iowa Core Curriculum, the same topic as recent institutes due to its popularity and increasing relevance for today's educators.

UI professors in the College of Education, Greg Hamot and Jason Harshman, led the group of 22 teachers for the two-day institute to find better ways to incorporate global perspectives into their classrooms. At the conclusion of the course, teachers prepared curriculum units which would be used in their classrooms and shared with fellow teachers in their hometown schools.

University of Iowa Liberal Arts Behind Bars

UI Liberal Arts Beyond Bars (UI LABB) completed its first year of programming at IMCC Oakdale, providing UI-credited liberal arts education to incarcerated men. LABB has conferred credits to almost 100 men over the past 3 semesters. Offerings include Rhetoric, Elementary Psychology, Foundations of Entrepreneurship, Elements of Art, Choir, the UI Speaker Series, and the first UI co-learning course, One Community, One Book. The program has introduced over 100 educators, community peer mentors, and guests into the prison. UI LABB program underwent significant administrative changes and formally moved into University College in Spring 2019 in order to build its capacity to deliver credit-bearing courses and create a sustainable, campus wide presence.

While UI LABB is no longer operating under the auspices of the Center, our staff and students remain highly engaged with and supportive of the work. We offered a spring session on "Introduction to Law" and hope to offer a full course in the Fall. We would like to thank staffer Kathrina Litchfield for all her work on steering UI LABB from its inception. We are delighted that the new UI LABB director Dr. Heather Erwin, UI Law class of 1999, is joining our board.

Nancy Flowers and UN Day

The Center co-sponsored, with others, the Iowa United Nations Association's UN Day visit by Nancy Flowers. Ms. Flowers is an internationally Renowned human rights educator who participated in myriad events throughout Iowa during her stay. In celebration of UN Day on October 24, Ms. Flowers was the keynote speaker at a panel dialogue in Iowa City titled "Bridging the Gap: A Conversation about Human Rights, Civil Rights, and Social Justice." Director Wing and advisory board member Jim McKinney were on the panel as well. Flowers was a guest speaker at the secondary social studies student teachers seminar in the College of Education.

Immigration Policy and Human Rights

This series consisted of three lectures in the Fall: "U.S. Immigration Policy Today: What Has and Hasn't Changed in Immigration Law and Politics" by Bram Elias, Clinical Associate Professor of Law at the UI College of Law; "National Policy, Local Impacts: Voices from Mt. Pleasant" featuring panelists who were involved in the response to large scale immigration law enforcement activities in Mt. Pleasant earlier this year; and "Immigration Policy in Iowa 2018" by Rita Bettis Austen, Legal Director for the ACLU of Iowa. The series continued in Spring 2019 and explored migration from international perspectives. An April 3 event featured the stories of asylum seekers from Honduras, a discussion of the origins of current mass migration from Central America, and a presentation on recent developments in asylum law by Drake University Legal Clinic Director (and UI College of Law alumnus) Suzie Pritchett. The event was cosponsored by the Iowa City Catholic Worker House and attended by approximately 80 people at the Iowa City Public Library.

International Day

On October 30, 2018, the 22nd International Day celebrated Article Two of the UN Universal Declaration of Human Rights, titled Freedom from Discrimination. Elizabeth Harano, the daughter of Japanese-American internment camp detainees, gave the keynote address. Co-sponsored by the UI Center for Human Rights, the College of Education, and the Stanley Foundation, a performance of Sadako by the Pointe Academy of Ballet and Contemporary Dance and 15 breakout sessions by UI community members filled the day for over 320 middle and junior high school students and teachers from Eastern Iowa.

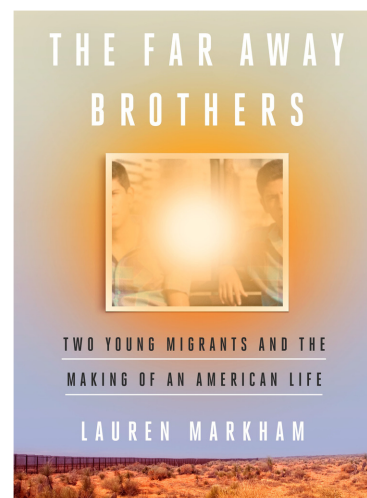
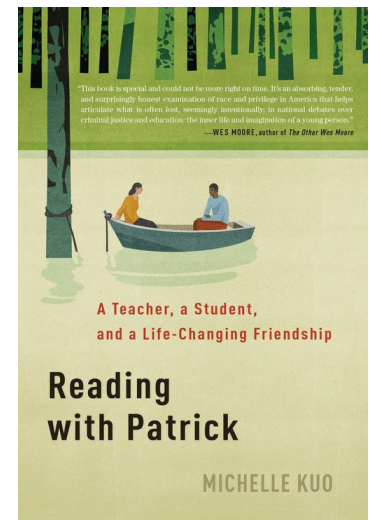
One Community, One Book

Reading With Patrick, the 2018 non-fiction finalist for the Dayton Literary Peace Prize, was UICHR's 2018 One Community, One Book (OCOB) selection. Author Michelle Kuo visited Iowa for two weeks in late October, attending 18 events over the course of her stay, and engaging with over 900 readers in our community. Her itinerary included speaking engagements at Coe College in Cedar Rapids; Muscatine Community College; UI classrooms in Library & Information Science, Rhetoric, Education, and Law; the Asian Pacific American Cultural Center; and several co-teaching opportunities at Oakdale Prison through the UI LABB program. Her final event, speaking at Shambaugh Auditorium, was a dialogue with returned citizen and college-in-prison alum, Kenneth Bailey.

The Faraway Brothers: Two Young Migrants and the Making of an American Life by Lauren Markham, the 2018 recipient of the Ridenhour Book Prize, is the 2019 OCOB selection. The book is a non-fiction account of the immigration journey of two teenage boys from El Salvador to the United States who arrive as "unaccompanied minors" and must build a new life on their own. The author will visit Iowa City October 3-5, 2019, in partnership with the Iowa City Book Festival and give a public lecture about her book on October 4. An event with the Center for Worker Justice of Eastern Iowa and the Iowa City Community School District is also planned, along with community wide book discussion fora.
